TRANSITION POLICY FOR PEFC STANDARD ST 2003:2020¹ - REQUIREMENTS FOR CERTIFICATION BODIES OPERATING CERTIFICATION AGAINST THE PEFC INTERNATIONAL CHAIN OF CUSTODY STANDARD AND AS 4707.

#### **BACKGROUND**

PEFC Standard ST 2003 underpins the accreditation processes for Certification Bodies operating in Australia and New Zealand accredited by JAS-ANZ and other IAF members to provide certification against:

- **1.** The PEFC International Chain of Custody Standard PEFC ST 2002 and/or;
- **2.** Australian Standard AS 4707-Chain of Custody for Forest Products.

PEFC ST 2003 was revised in February 2020 and this policy provides guidance to accredited Certification Bodies, JAS-ANZ and other Accreditation Bodies on the implementation of PEFC ST 2003:2020 and migration from the 2012 version.

#### **POLICY**

- **1.** Certification Bodies **cannot** offer certification to **PEFC ST 2002:2020-**Chain of Custody of Forest and Tree Based Products and **PEFC ST 2001:2020** Trademark Rules-Requirements, until such time as their Scope of Accreditation has been amended to include the 2020 versions of these Standards<sup>2</sup> and CB REQUIREMENTS TO **PEFC ST 2003:2020.**
- **2.** For a Certification Body to be accredited, key personnel must undertake mandatory PEFC recognized Chain of Custody and Trademark training<sup>3</sup> to the requirements of the 2020 version of PEFC ST 2001 and PEFC ST 2002.

**NOTE 1:** See references for Standards designations.

**Note 2:** Certificates issued to the 2020 versions of Standards are not recognized by PEFC until the CBs Scope of Accreditation has been extended to include these Standards.

**Note 3:** This training is under development and will be available through PEFC and/or Responsible Wood in the near future.



- 3. Following mandatory training (See Clause 2), Certification Bodies will need to contact their Accreditation Body to arrange an assessment to the requirements of PEFC 2003:2020. Once the Scope of Accreditation has been updated to include PEFC ST 2001:2020 and PEFC ST 2002:2020, certificates may be issued to the 2020 CoC and Trademark Standards.
- **4.** Audits including initial, recertification and surveillance, to the superseded **2013** version of PEFC **ST 2002** can be performed until **14**<sup>th</sup> **August 2022**.
- **5.** From **15**<sup>th</sup> **August 2022**, audits must be to the current **2020** versions of PEFC **ST 2001**, PEFC **ST 2002**.
- **6.** From **15**<sup>th</sup> **August 2022**, audits to AS4707 will only be recognized where the CB is accredited to **PEFC ST 2003:2020**.
- **7.** All Certification Bodies providing PEFC endorsed Chain of Custody audits to either **PEFC ST 2002:2020** or **AS 4707**-Chain of Custody for Forest Products, must be working towards having their Scope of Accreditation updated to the 2020 Accreditation and Certification Standards by **14**<sup>th</sup> **August 2022**.
- **8.** On **14**<sup>th</sup> **August 2023** certificates issued to **PEFC ST 2002:2013** (and **AS4707** for CBs accredited to **PEFC ST 2003:2012**) will no longer be recognized and recognition to audit PEFC and Responsible Wood CoC systems will lapse where accreditation is not in accordance with **PEFC ST 2003:2020**.
- **9.** It is anticipated that further details for AS 4707 transition management will be published in the near future.
