Responsible Wood Annual review of activities 2020 - 2021



Chairman's Report

On behalf of the Directors, I am pleased to present the 2020/21 Responsible Wood Annual Report. We have completed a very busy and productive year, despite early concerns about the impact of Covid on our business. As we all now know the past year has been one of buoyancy for the forest sector and this has translated into continuing support and demand for certification services.

A major focus over the last year has been the revision of our two Standards for Sustainable Forest Management and Chain-of-Custody. Drafts were exhibited for public comment and final revisions were completed by year end, with only formal approval procedures remaining. The revision of the SFM standard, jointly with New Zealand was a particularly significant body of work and great credit goes to the bi-national multi-stakeholder working group, ably chaired by Dr Gordan Duff for completing this revision.

Our productive partnership with the New Zealand Forest Certification Association

has continued with this finalisation of the joint AS/NZ forest management standard while management and promotion of the NZ scheme has been actively pursued, despite Covid travel restrictions. We remain in close contact with the NZ Forest Certification Association, with joint Board meetings from time to time.

We rolled out our Community Grants Program, which was a great success with six community organisations working in partnership with certified forests funded across four States. We will continue with this program which contributes to our goal of enhancing community engagement and understanding of forest certification.

Furthering our commitment to the promotion of PEFC in our export markets, we partnered with our Australian certificate holders, PEFC International and PEFC Japan in the recruitment of a full-time marketing resource to support Australian Responsible Wood/ PEFC certified suppliers in the Japanese market.

Your Board has commenced a process of strategic review and renewal, including an audit of our marketing and brand programs, and risk procedures. We updated our risk management policy and register to better reflect a revised international risk management standard.

We are concerned to note the continued pressures to remove wood production as a future option from Australia's certified native forests, at a time when preserving such options becomes more important to meet the challenges of our future world. We will increase our focus on building relationships and engagement with our members, certificate holders and wider stakeholders to develop stronger understanding and commitment to SFM, to our SFM standards and the RW trust mark. We plan to increase resourcing in our SFM capability to widen our engagement with relevant stakeholders including in the spaces of climate change, indigenous forestry and smaller forest growers.

Responsible Wood remains in a strong financial position. Despite a conservative budget based on concerns about Covid impact on our members and certificate holders, revenues were maintained through the year, while continued Covid restrictions on travel and meetings, and deferral of some new initiatives, resulted in an above budget surplus. This has positioned us well for progressing the new strategic initiatives for which planning commenced during the year.

Mark Gauthier was elected to the Board by forest grower members and Dr Tony Bartlett was appointed as an independent director during the year. I wish to acknowledge the contribution of retiring director Willie van Niekerk and thank him for his dedication and input.

I wish to thank all Responsible Wood staff, particularly Simon Dorries, who continues to put in sterling efforts and my fellow Directors for their dedication and professionalism in the governance of Responsible Wood in the interests or all our members, certificate holders and stakeholders. The achievements of Responsible Wood this year are a compliment to them all.

Finally, we thank all our members, certificate holders, working group members and supporters who have contributed enthusiastically and continued to support us and our mission for sustainable forest

management.



Responsible Wood (The Australian Forestry Standard trading as Responsible Wood) is a notfor-profit public company that promotes the sustainable management of Australia's forests and traceability of wood products, through its management of the Responsible Wood Certification Scheme (RWCS).

We are a Standards Development Organisation accredited by the Standards Development and Accreditation Committee of Standards Australia (SDAC) to develop and maintain Australian Standards® within its scope of accreditation.

We are the Australian member of the Programme for the Endorsement of Forest Certification (PEFC). The RWCS is one of 49 national forest certification schemes endorsed by the PEFC.


Each year, we publish our Annual Review of Activities to inform members, stakeholders and the public of its progress in administering the RWCS.

Responsible Wood Certification Scheme

The Responsible Wood Certification Scheme sets out the specifications and procedures that ensure the highest standards of management, transparency and accountability in Australia's forest sector.

Two Australian Standards sit at the heart of the Responsible Wood Certification Scheme - the Australian Standard® for Sustainable Forest Management (AS 4708) and the Australian Standard® for Chain of Custody of Forest Products (AS 4707). Australian Standard® AS 4708 provides reassurance to consumers of wood and paper products that the forests from which those products originated are independently audited and verified as well managed. Obtaining certification demonstrates that management practices meet requirements for best practice in sustainable forest management, including:

- biodiversity of forest ecosystems is maintained or enhanced
- the range of ecosystem services that forests provide is sustained because they:

o provide food, fibre, biomass and wood
o are a key part of the water cycle, act as sinks capturing and storing carbon, and prevent soil erosion

- provide habitats and shelter for people and wildlife; and
- o offer spiritual and recreational benefits
- chemicals are substituted by natural alternatives or their use is minimised
- workers' rights and welfare are protected
- local employment is encouraged
- Indigenous peoples' rights are respected
- communities have an opportunity to provide input into the process.

Chain of custody certification against Australian Standard® AS 4707 ensures requirements for tracking certified material from the forest to the final product are met and that the wood contained in the product or product line originates from certified forests and controlled sources.

Internationally, the Responsible Wood Forest Certification Scheme is endorsed by PEFC, the world's largest sustainable forest certification scheme, which sets high standards for forest certification and sustainable forest management in line with society's ever evolving understanding and expectations.

The Standards are reviewed every five years to ensure they represent best management practice and reflect community expectations.



In addition to routine activities, we launched the Responsible Wood **Community Grants Program for** 2020-21, an initiative aimed at supporting local communities connected to Responsible Wood certified forests throughout Australia.

Community Grants were awarded for collaborative community-based projects, activities or events that connect local communities to Responsible Wood certified forests.



Six community groups were awarded grants (totalling more than \$45,000). Grants were provided to communities in South Australia, Victoria, New South Wales and Queensland.



We are, in partnership with PEFC International and Australian sponsors, providing a full-time marketing resource to support Australian Responsible Wood/PEFC certified suppliers in the Japanese market.

Tokyo-based Japan Marketing Manager, Ms Makiko Horio, is reaching out to a wide range of PEFC brand users in Japan to promote PEFC certified forest fibre to a wide range

of businesses. In addition, Ms Horio is also exploring new ways of communicating information, research and certification systems to the wider Japanese industry.

We unveiled an updated website at the Responsible Wood 2021 AGM in October. The new website improves user experience for members, certificate holders and consumers of Responsible Wood certified products.

Our scheme continues to grow from strength to strength with an increasing number of members and scheme holders using the Responsible Wood brand in the marketplace. Despite global uncertainly, demand for Responsible Wood and PEFC forest certification remains steady as we continue to reach out to specifiers and consumers of forest-based products.

We thank our members and stakeholders for their ongoing support, feedback and input in this extensive process.

Reviewing Our Standards

Following a comprehensive review, the revised AS 4707 Chain of Custody of Forest and Tree Based Products was approved for publication in September 2021. The review ensures the Standard incorporates the latest knowledge, best practices and evolving stakeholder expectations, as well as ensuring consistency with current PEFC requirements. The five-yearly revision of AS 4708 Sustainable Forest Management continued for the period and is nearing completion. The revised Standard incorporates the latest knowledge, best practices, and evolving stakeholder expectations. The review is being undertaken in conjunction with Standards New Zealand with the expectation that the new Standard will be a joint Australian/New Zealand Standard suitable for delivering Sustainable Forest Management in Australia and New Zealand (AS/NZS 4708: 20XX -Sustainable Forest Management principles). We received approximately 400 pieces of public consultation following the release of the public comment draft AS/NZS 4708 Sustainable Forest Management principles standard in August 2020. The revised Standard is to be balloted by the Standards Reference Body, with the final publication of the AS/NZS 4708 Sustainable Forest Management principles standard expected during the 2021–22 financial year.

This is a fundamental requirement of our accreditation as a Standards Development Organisation (SDO) by the Standards Development and Accreditation Committee



(SDAC) and the ongoing endorsement of the RWCS by PEFC International.

In addition to operating and maintaining the RWCS, we continue to operate as the PEFC National Governing Body for Australia and provides administrative services for the New Zealand program on behalf of the New Zealand Forest Certification Association (NZFCA).

Certification

Forest management certification

The total area of certified forest in Australia, the sum of the individual Defined Forest Areas (DFA), has increased to 16.28 ha with new areas of sandalwood production in Western Australia brought into the scheme. This represents a 45% increase in DFAs over the 2019–20 period. The total number of forest management certificates is 29, unchanged from 2019–20.




The majority of Australia's commercial production forests (i.e., plantations and native forests) continued to be certified against the Australian Forestry Standard (AS 4708 Sustainable Forest Management).

RFF (formerly Reliance Forest Fibre Group Scheme) and the Forest Smart Group Certification Scheme administered by PF Olsen Australia Pty Ltd are currently registered for Group Certification under the Responsible Wood Certification Scheme. Group Certification is where small independent forest managers form a co-operative or group for the collective certification of the forests in which they manage. Group Certification defrays the certification and management costs over a larger number of participants, making forest certification more cost effective and accessible to small forest growers.

Chain of Custody certification

Responsible Wood recognises chain of custody certificates issued against the Australian Standard® (AS 4707 Chain of custody for forest products) and the PEFC Standard (PEFC ST 2002:2020 Chain of

The total number of chain of custody certificate sites administered by Responsible Wood has increased from 304 to 316 as at 30 June 2020. This total includes both Chain of Custody certificates issued for New Zealand and Group Chain of Custody in Australia.

Group Chain of Custody Certification has grown strongly with 38 individual companies now participating in Group Chain of Custody, under two individual certificates.

Accredited certification bodies

Five certification bodies are now accredited by JAS–ANZ to issue Forest Management certificates in Australia or New Zealand to AS 4708 or NZ AS 4708. In addition, fifteen certification bodies are accredited to provide Chain of Custody in Australia against the PEFC Chain of Custody Standard or AS 4707. In New Zealand, three certification bodies have been notified to issue Forest Management Certificates to NZ AS 4708 and eight to provide PEFC Chain of Custody Certification.

We continued to provide the mandatory training to certification bodies to ensure they meet the training provisions and competencies required by JAS-ANZ and other accreditation bodies. In addition, we have also provided specific training to certification bodies required to extend their JAS-ANZ Scope of Accreditation to provide certification in New Zealand.

We have continued engagement with certification bodies by facilitating workshops. The 2020-21 workshop was delivered remotely in August 2020 and was attended by 24 staff representing most certification bodies operating in Australia and New Zealand. Delivered remotely for the first time, the workshop had a significantly larger turnout than previous years. In addition to certification bodies, the workshops were attended by our staff and JAS-ANZ. The workshops provide a forum where certification and accreditation requirements (including new provisions) are discussed, changes and updates to Standards are reviewed, the activities of Responsible Wood and PEFC are communicated, and feedback on the operation of the certification scheme is provided. Attendance at these workshops is recognised by JAS-ANZ as contributing to the mandatory training required by the relevant scheme rules.

PEFC in New Zealand

We have continued to administer the PEFC scheme in New Zealand on behalf of the New Zealand Forest Certification Association (NZFCA). NZFCA is the PEFC Governing Body for New Zealand. There are now five Forest

registrations and notifications, take enquires and applications from New Zealand, liaise with certification bodies, and ensure that the scheme rules administered by JAS-ANZ are applied in New Zealand, as they are in Australia.

Richard Stanton Award for Excellence

In 2015, AFS Ltd established the Richard Stanton Award for excellence as an ongoing memorial to the late AFS National Secretary, Richard Stanton. The Richard Stanton Award is given to an individual demonstrating excellence and is open to individuals who have made a significant contribution to, or can demonstrate:

- 1. Innovation, improvement or excellence in Forest Management or Chain of Custody Certification.
- 2. A strong commitment to the Responsible Wood Certification Scheme and sustainable forest Management.

The winner of the 2020 Richard Stanton Award for Excellence was Mr Simon Cook, Sustainability Manager for Responsible Wood certified Forest Grower, Forico.

Mr Cook leads a five-member Sustainability Team, and in this role has worked tirelessly to initiate and drive sustainable forest management activities in areas of biodiversity, carbon, and cultural values, leaving a lasting legacy both inside the forest and outside.

The nomination was made by Ms Ann La Sala, a member of Mr Cook's sustainability team, and was supported and endorsed by Forico.

Mr Cook's involvement with Tasmanian Devil Facial Tumour Disease is especially noteworthy. The program not only assists in understanding how cancer affects Tasmanian Devils, but also has potential implications for cancer treatment in humans and is attracting global attention.

Working with CSIRO and other industry partners, Mr Cook has been instrumental in developing a framework and methodology for assessing and gathering data related to Natural Capital. This developing area will have significant implications for forest sustainability globally as foresters seek to develop a common language and understanding in this emerging area.

And finally, working on developing a Reconciliation Action Plan in conjunction with Reconciliation Tasmania, Mr Cook is working with stakeholders to improve relationships with the Tasmanian Aboriginal Community through sharing knowledge of

land management techniques, protecting cultural sites, improving access to natural forests, and increasing potential employment opportunities.

All of these areas embody important elements of the Responsible Wood standard.

We were delighted to receive a large number of high quality nominations.

Accordingly, for the first time, three finalists were recognised by our judging panel. Finalists included Mr Richard Kirk of Kirk Architects for his commitment to the use of certified timber on the acclaimed Mon Repos Turtle Centre; the QDAF Salisbury Research Facility for their pioneering work

Standards & Accreditation

Responsible Wood is one of only five Australian entities accredited as a Standards Development Organisation (SDO) by the Standards Development and Accreditation Committee (SDAC). SDAC sits under the Board of Standards Australia. Accordingly, we were subject to our yearly surveillance audit by an SDAC appointed auditor in December 2020. The result was excellent with no non-conforming practices identified. As a result of the audit, SDAC accreditation of Responsible Wood as an SDO to develop Australian Standards[®] for forest management and Australian Standards® that support the Australian Forest Certification Scheme, was maintained.

PEFC

The Responsible Wood Certification Scheme (RWCS) is endorsed by the Programme for Endorsement of Forest Certification (PEFC), an international non-profit, nongovernmental organisation dedicated to promoting Sustainable Forest Management (SFM) through independent third-party certification. PEFC is recognised in 55 counties through National Governing Bodies and has 49 endorsed national certification systems and approximately 330 million hectares of certified forests. PEFC is the world's largest forest certification system covering approximately 20,000 individual sites and representing over 750,000 individual forest owners. PEFC certifies approximately three quarters of all certified forests globally.

PEFC is an umbrella organisation. It works by endorsing national forest certification systems developed through multistakeholder processes and tailored to local priorities and conditions. To ensure consistency across all PEFC-endorsed standards, all national systems wishing to be PEFC recognised undergo rigorous independent assessment to ensure their

- the complaints and appeals mechanism.

We remain active within the PEFC organisation and were represented on three Standards Committees:

- Working Group One: Sustainable Forest Management
- Working Group Two: Group Certification and Requirements for Certification Bodies
- Working Group Three: Standards Setting Requirements.

We are an active member of the Customer Engagement Group (CEG), the Construction Products Task Force and the Asia-Pacific Asia Promotions Initiative (APAC Hub) — an initiative that we chair. The CEG is responsible for advising PEFC on marketing, industry, and consumer engagement strategies. One key recommendation from the CEG was the PEFC sponsorship and support for the Sustainable Timber Award at the World Architectural Festival (WAF). This prestigious award recognises the best architectural designs utilising sustainably sourced timber products.

Responsible Wood Director, Ms Katie Fowden, was appointed to the PEFC Marketing, Communications and Advocacy Working Group, representing Australia and New Zealand. This group is tasked to further develop consistent, global, strategic, and tactical approaches to deliver the overall PEFC strategy, vision, and mission.

Standards Review - PEFC Standards

PEFC maintains a suite of Standards and Guides. Standards and guides currently under review include:

- Requirements for Certification Bodies providing Chain of Custody Certification,
 PEFC (ST 2003) – Guidance Materials
- Chain of Custody of Forest and Tree Based

Marketing & Communications

Our marketing and communications activity has continued at a strong pace despite the COVID-19 pandemic. Returning marketing spend to pre-pandemic levels, we have increased investment in digital marketing and communications; redeploying spend that would normally be allocated to Australian and overseas travel.

In addition, we continue to be a major content generator of media and communications within the Australian forest products industry.

In June 2021, we commissioned Fresh PR and Marketing to undertake a brand audit of the Responsible Wood brand. The scope of the brand audit evaluated our brand's position in the marketplace, our strengths and weaknesses, and how we can strengthen our position. The scope of the audit was extensive and the findings highly valuable. The recommendations of the final report will be integrated into our Marketing Plan.

In November 2020, we commissioned Primal Agency to refresh our website. The new website now aligns with the PEFC website and utilises modern technology to drive traffic to www.responsiblewood.org.au. Since June 2021, we have received more than 80 items of overwhelmingly positive feedback. The launch date will coincide with the October 2021 AGM.

We have met with a number of the 2020–21 Community Grant recipients in person where Covid-19 travel restrictions allow or online. Highlights include:

- Slab hut launch: economic advantages to grow local for forest communities
- Exploring Boandik Creation stories at Mt Burr Swamp

• The Bennett's Trails: A story of resilience, collaboration and blisters.

The numbers indicate that we have continued to grow our advertising footprint - diversifying from traditional media to digital media platforms. The by-product of increased advertising traffic is that we have experienced heightened inquiry from consumers of forest products and Chain of Custody certificate holders.

We have renewed our long-term sponsorship of the Australian Timber Design Awards, Certified Timber, and remain a strong supporter of the World Architectural Festival (WAF), Best Use of Certified Timber category sponsored by PEFC International.

limited by guarantee. Membership of Responsible Wood is open to all organisations and individuals who support the Objectives of the company as set out in the Constitution. As of 30 June 2021, we have 35 members, unchanged from 2019-20.

Governance

The Directors Report and Audited Financial Reports for 2020-21 was prepared and provided to our Members prior to the 2021 AGM, in accordance with the Corporations Act 2001 requirements.

In accordance with the Responsible Wood Constitution, three Directors are required to retire at each AGM. The Directors retiring in 2019 were Mr Willie Van Niekerk, Ms Katie Fowden and Mr Craig Smith.


Following his resignation, Mr Willie Niekerk was replaced by Mr Mark Gauthier as the Director nominated by Forest Grower

Members. Ms Katie Fowden was re-nominated and was reappointed in a ballot by Primary Processors Members. Mr Craig Smith was reappointed unopposed to the Board, nominated by Employee Representative Organisations.

Dr Hans Drielsma, Mr Craig Smith, Ms Katie Fowden, Mr Stuart West, Mr Mark Thomson, Ms Patrizia Torelli, Mr Mark Gauthier and Dr Tony Bartlett continued to serve through 2020–21 as Directors appointed by the Members, while Dr Hans Drielsma continued to serve as Chair.

Finance

The audited accounts show the financial outcome for Responsible Wood for 2020–21 was a surplus of \$252,128 (2019–20 — \$207,656) increasing Net Assets (Total Equity) to \$1,764,714 (2019–20 — \$1,512,586). Net Current Assets improved from \$1,501,461 as of

30 June 2020 to \$ 1,756,187 on 30 June 2021. Cash increased by \$229,399 over the year to \$1,453,485 as at 30 June 2021.

We are a not-for-profit company. The Board has sought to maintain a reserve to ensure that the company can operate effectively and manage any future changes in financial circumstances in an orderly manner. This is especially relevant due to the unknown and uncertain impacts on the Australian economy, and we are fortunate to enter these uncertain times with strong resources. The Board intends to continue investing funds in the development and promotion of the Responsible Wood scheme, the Responsible Wood brand and market development in support of sustainable forest management. We will seek to increase the value added to our members and certificate holders whose support of sustainable forest

In May 2021, Responsible Wood celebrated the first-ever 'Australian Made Week.' Responsible Wood is a proud campaign associate of the Australian Made, Australian Grown campaign.
